NOTES

1. Please notify Ocean Youth Trust Scotland if you change your name or address while the declaration is still in force.
2. You can cancel the declaration at any time by notifying Ocean Youth Trust Scotland – it will then not apply to donations you make on or after the date of cancellation or such later date as you specify.
3. If in the future your circumstances change and you no longer pay tax on your income and capital gains equal to the tax that Ocean Youth Trust Scotland reclaims, you can cancel your declaration
4. If you pay tax at the higher rate, you can claim further tax relief in your Self Assessment tax return.
5. If you are unsure whether your donations qualify for Gift Aid tax relief, ask Ocean Youth Trust Scotland. Alternatively, you may ask your local tax office for leaflet IR 113 Gift Aid.
